6.3. Quality improvement strategies adopted by the institution for each of the following:

6.3.1. Curriculum Development

University of Kerala had revised both PG and UG syllabi from 2016 and 2017 admission onwards and the revisions were implemented. The teachers from all the departments were contributed to the syllabi revision tenure as members in board of studies and academic council.

6.3.2. Teaching and Learning

The teaching and learning process effectively functions in such a way that information is passed to students in conventional ways and using ICT enabled platforms. Teachers resort to the use of internet, e- books, e-journals, reference material, smart classrooms, ICT enabled language labs, ICT enabled practicals, ICT enabled teaching debates, field work and study tours. Students are provided exposure in reputed laboratories by arranging visits. Similarly, classes handled by experts are provided through EDUSAT facility available in the College. Students are exposed to emerging areas by arranging seminars/workshops and invited talks.

The "moodle" software is uploaded in the college website for the effective teaching learning process and easy access of teachers to students.

The college has a College Level Monitoring Committee (CLMC) and Department Level Monitoring Committees (DLMCs) to monitor the proper conduct of internal examinations, assignments and projects in connection with the CBCSS. As part of quality strategy, the College Council decided to conduct internal examinations in proper time as per university schedule for CBCS system. The timely declaration of results, its publication and settling of grievances are other strategies implemented.

6.3.4. Research and Development

- ➤ Information obtained from various sources regarding Research projects, schemes, funding agencies, application forms etc are made available to the staff as well as students.
- ➤ All possible facilities are provided.
- ➤ Details regarding Minor and Major Research Projects and Post-doctoral fellowships are intimated timely.
- > Necessary steps are taken by the research committee for the timely procurement and release of funds.
- Facilities like lab, library etc. is provided for research scholars. Timely auditing, submission of utilization certificate to the funding authority are monitored by the research committee.

6.3.5. Library, ICT and physical infrastructure / instrumentation

The college has introduced INFLIBNET facility in the general library. Research scholars and teachers are highly benefitted by this. The computer lab of

the dept. of Mathematics has been equipped with networking facility. All the Science departments are connected by LAN facility.

6.3.6. Human Resource Management

All the teachers have been given additional charges of internal evaluation of one of the classes under CBCSS system and charges of new clubs started as a part of new curriculum. Some teachers are working as nodal officers for various new initiatives of the Government of Kerala such as Additional Skill Acquisition Programme (ASAP), Scholar Support Programme (SSP), Walk With a Scholar (WWS) etc and various committees like Planning Committee, Building Committee, Purchase Committee, Library Committee etc.

6.3.7. Faculty and Staff recruitment

The college has no role in recruitment as it is under Kerala government rules. All the recruitments are done by the Kerala Public Service Commission as per UGC guide lines. The guest lecturers are appointed by the college on the basis of merit and their performance in the interview, strictly following the rules and regulations of Govt. of Kerala.

Best Practice 1.

Title: Continuing Education Subcentre, Govt. College for Women, TVPM

Goal: We have set for ourselves the target of educating every single student who enters the portals of this college and equipping her both for life and for a living. As the purpose of education is to mould an individual into a good human being, efforts have been taken by the college authorities to cultivate personal skills needed for a good life. As the saying goes, 'If you educate a man, you educate an individual, but if you educate a woman, you educate a family and a Nation'. Training the students (girls) for self-employment will not only help them but also their family. This awareness makes us regard the whole venture as very noble and edifying. We hence rededicate ourselves to our task at this juncture. In addition to class room teaching, we take special interest in nurturing the various skills left unnoticed in our students.

The Practice is designed not only for the students of this college but for the empowerment of women of all ages and different academic qualifications in the society also.

The Context: Around 750 new students join this college every year. Even though the college is situated at the heart of the city, most of the students come from rural areas and that too from poor economic background. We understand that they have no other means to develop their inborn talents. So we organize a wide range of courses and programmes for developing soft skills, life skills, and entrepreneurial skills, artistic and academic talents.

Continuing Education Sub Centre is an Institution run in the Government College for Women for the last sixteen years. This Sub Centre comes under the Government of Kerala Initiative, Centre for Continuing Education, Kerala. There are at present 14 teachers and three office staff under this sub centre which was started with the aim of equipping women employementally self reliant. This sub centre is under the control of a 13 member advisory committee with the Principal of the College as President and a teacher of the College as Manager.

<u>The Practice</u>: Students who get enrolled in this college are welcomed with an induction meeting in which they are imbibed with an awareness of the tradition and history

of the college, the various programmes that are offered as well as the rules and regulations to be observed in the campus. The Continuing Education Sub Centre of the college offers a large number of skill development courses. The sub centre is set up with the objective of conducting non-formal courses and to help women gain skills and knowledge, and to provide training that could lead to jobs or often self - employment. At present the sub centre offers 340 courses, which include training in various skills, interior decoration, toy making, embroidery and craft, beautician courses, fashion designing, spoken Arabic, English, French and German and numerous painting and computer courses. All these are self-financing courses. The sub centre thus generates its own resources and a share of the profit earned is given to the college, which in turn, is utilized for its development. Thus the students are getting double benefit out of the sub centre. They are equipped with skills which enable them to seek self-employment and to be responsible citizens who are useful to the society.

As there is no age limit for attending courses in this centre, students ranging from the age of 3 to 75 are undergoing training on various courses. In the IT sector, diploma in computer application and short term courses like MS office, Data entry, DTP and Tally are being conducted. All these are Govt. of Kerala approved courses, and students get benefit on KPSC appointments. The sub centre is conducting another Govt. approved diploma course on Beauty therapy and beauty parlour management, of duration three months. We got approval for a one year course of diploma in fashion designing and will be started in due course. In addition to these, several short term courses like painting, stitching, craft etc are also being conducted.

The students belonging to SC, ST and BPL categories are giving fee concession for Govt. approved courses. For the college going students, separate classes are being conducted during 7.30 to 9.30 am and 3.30 to 5.00 pm. As a result of this the students can come out of the college after studying a job oriented courses also. Apart from this, short-term courses like Cooking, Yoga and Music is being conducted for house wives.

All the courses conducted in this centre have separate syllabus. The syllabus followed for Govt. approved courses are directed and approved by CCEK and KPSC respectively. The syllabus for other programmes are being prepared by the concerned teachers of the sub centre and submitted to the CCEK for approval, after placing the Advisory Committee of the sub centre. The courses will be conducted after getting approval from the CCEK.

The examination pattern for the Govt. approved courses is as per CCEK, conducted by the Controller of Examinations of CCEK and the certificates are issued to the students by the centre directly. Examinations for other short term programmes are being conducted by the concerned Faculty members. Those who fail in the examination are given the chance to appear for the examination along with the next batch.

Evidence of Success: The centre is now conducting around 340 courses and about 14000 persons have successfully completed their studies from this centre. Several students who passed from this centre were able to start self employment. Many students have secured employment in various govt/ private firms.

<u>Problems Encountered and Resources Required:</u> The Income and Expenditure Statement of the sub centre is being got audited every financial year without fail. 15% of the amount acquired by the Sub centre every year as profit is being given to the CCEK. So also financial assistance for the developmental activities of the college as per the guidelines of

CCEK, is being given every year from the income of the Sub centre. The sub centre is completely self financing and is not getting fund from any other sources. So the remuneration of the faculties in the sub centre depends on the availability of students in each course and hence sometimes they cannot be remunerated properly.

Best Practice 2.

Title: LAB FOR LEARNING AND LIFE SKILLS (L³)

Goal:

Providing support for students on academic programmes is one of the key roles of a University teacher. It is not just about providing students with an engaging learning environment in which the conditions have been established for engaging students with the teacher, the content and with one another. It is about looking more specifically at what individual students might need by way of support. It is very important that you identify the learning needs of students in order to provide the right level, type and amount of support. Typical areas for support may include study skills (such as revising, planning learning, time management, using the library and online databases), academic writing, numeracy and data handling and writing in English. L^3 – Lab for learning and life skills serves as a space for temporary or prearranged meetings and discussions with peers—perhaps to work on a project or group assignment, or to provide mentoring and support through the sharing of experiences and expertise. In short, L³ is a room designed and created for students, especially the post graduate students and research scholars to sit, relax and work in a relaxed environment, with all the infra structural and technological facilities. As far as a postgraduate student is concerned, it is highly mandatory that, they need to do seminars, presentations and have to identify their research areas and prepare research designs for a good research work. This requires a flexible and inductive learning environment other than a classroom where one can freely discuss her/his ideas with one or two friends and can correct them. Not all students are self-motivated and confident learners; some require more time to understand a subject and may need concepts defined in new ways or to be shown another approach to learning the material.

Understanding the necessity of such smart learning spaces in our campus, a group of FLAIR faculty members, who were interested in bringing innovations in classroom management and those who underwent an international internship, sat together and framed a 25 hour module programme on "Research Skills & Practice". They represent the facilitating team of the hub. The aim of the programme offered through L^3 , is to assist the students to have sound

knowledge in research and to develop in them professional competencies needed for a researcher. Following learning objectives where thus identified:

- i) To familiarize the post graduate students about the research process & impart specific skills required to conduct research and life skills.
- ii) To assist the students to gain knowledge to conduct independent research.
- iii) To equip them for making research presentations.

A student who undertakes a programme on "Research Skills and Practice", is expected to develop certain Key skills such as Critical thinking for research; Problem solving related to research; research & writing and communication skills, and certain life skills such as Critical thinking, Problem Solving, presentation and communication skills.

The Context:

Lab for Learning and Life skills is the first of its kind, among the Government Arts and Science Colleges in the State of Kerala. It was conceived and developed as a best practice by Dr.Sithara Balan V, Dept of Home Science and a FLAIR International Intern, who underwent her international internship at University of Southampton during 2013-14. Further it was developed as a project with the help of the Department of Home Science and College. It was funded by the Directorate of Higher Education Govt of Kerala and guided by the Office of the New Initiatives of Govt of Kerala and FLAIR Secretariate. L³ was officially inaugurated on 24, August 2015 by the then Director of Collegiate Eduction- Shri. M.Nandakumar IAS. Prof Sabu S Padmadas, Prof of Demography and Global health, University of Southampton, United Kingdom was the chief guest of the programme. The lab was designed and constructed by Habitat Group of Technologies, led by Padmashree R.Shankar.

All FLAIR Interns of the college, who underwent an international internship of four week duration, are voluntarily acting as facilitators for the programme. The facilitating team has been restricted to international interns, only because of their specific knowledge in developing and designing courses, the nature of training programmes that they underwent, interest and initiatives in bringing innovative changes in the classroom management, their willingness to work extra time without any additional benefits etc. However, any faculty who is genuinely interested for the welfare of the hub, can act as a resource person, to exchange their research ideas, share their experiences and facilitating the students to involve in the research process, are free to join.

The Practice:

A student who attends the programme on "Research Skills & Practice" should be able to:

- 1. Frame a research topic
- 2. Conduct literature review
- 3. Identify and apply appropriate research methodologies
- 4. Construct and implement a realistic research timetable
- 5. Deliver a presentation on a chosen research topic
- 6. Critically reflect on data produced & to disseminate the same

7. Critically reflect on the ethical considerations of their chosen research topic

Postgraduate students from third and fourth semesters are the target group of the L³. The hub provides them a flexible learning environment to sit, relax and work with peers in the preparation of seminars, presentations, research proposals, reviewing the literature, understanding the audience for scientific writing and preparation for student projects.

All postgraduate students of the college, who has a flair for research can apply to the programme offered by L³, irrespective of their discipline. However, the selection shall be based on the following criteria's:

- A proven track record of academic excellence
- Strong aspiration towards research
- Needy and deserving
- Positive approach and commitment
- Nominated by Head of the Department (one or two student from each department)

The final selection of the student will be done based on an Aptitude test and will be purely on the discretion of the L³ Facilitating team.

As a pilot phase, students from the parent departments of the facilitating faculties were given training during the academic year 2015-16 and the feedback was motivating. More and more students started approaching the hub and it was decided not to limit the programme to any disciplines, instead any student who is really interested in knowing more about research are given a chance. Five students each from the Department of Home Science, Economics, Psychology, Commerce and Philosophy were selected through the selection process. They were given 25 hour training on research skills, research review and presentation skills. A team of 5 faculty members from the University of Southampton, United Kingdom visited them and interacted and exchanged their ideas with the students. The students prepared charts and posters on research and they actively participated in all the deliberations carried over there.

During the academic year 2017-18; the module developed was redesigned using the principles of ADDIE model. Due to the over whelming responses from the students and frequent enquiries, all post graduate students who have flair in research, were given a chance to apply for the programme. A total of 25 applications were received this year. Ten students from the specializations of Chemistry, Psychology, Economics, Business Economics, Commerce and Philosophy were selected through aptitude test and interview. Each facilitator has been assigned a day for meeting the students and she is in charge for a particular module. Together with the students, they share, discuss and debate on the processes involved in research. Majority of the sessions were activity oriented and were given hands on experience on identifying a topic, reviewing the literature, scientific writing etc.

Essential infra structure of the learning hub:

A computer, internet connectivity, comfortable working chairs, tables/ desks, quiet spaces, and screened-in areas for small work groups.

Future activities:

- ➤ Discussions with faculty members from both inside and outside the campus, who underwent higher studies on research through fellowships like- Raman fellowship, Fulbright, Kothari etc.
- ➤ Virtual collaboration with faculty and research scholars from both the Internship departments of the FLAIR Interns as well as through collaborations.
- ➤ Publishing annual newsletter based on the students insights on research.
- Talks with research scholars of the college, and also sessions on research methodology by the L3 students for other students of the college.

Evidence of Success:

Understanding the necessity of smart learning spaces and the need for introducing skill labs in the Colleges, many more colleges started replicating the concept of L3. The Academic Skill Hub of Govt College, Kottayam and the Skill Hub of All Saints College, Thiruvananthapuram are few examples.

Problems encountered and resources required:

Power supply failure and lack of permanent facilities and arrangements for internet and wi-fi are a major constraint for the hub. Since, the room was designed in the already existing space of a department library; the seating capacity for students is limited to 6 at a time. The number of students who are interested to attend the programme is increasing day by day, but the spacing and resources are a real matter of concern. A high speed internet facility and an LED TV for display are very essential for establishing and arranging skype interactions with eminent faculties across the globe. Lack of multidisciplinary journals is also a matter of concern.


