

**FORM OF QUOTATION NOTICE**

Sealed quotations are invited for the supply of the materials specified in the schedule attached below/overleaf. The rates quoted should be for delivery of the articles at the place mentioned below the schedule. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above. Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for delivery of the articles should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or 'subject to prior sale' condition are liable to be rejected.

The acceptance of the quotations will be subject to the following conditions:

1. Acceptance of the quotation constitutes a concluded contract. Nevertheless, the successful tenderer must within a fortnight/a month after the acceptance of his quotation furnish 5 per cent of the amount of the contract as security deposit and execute an agreement at his own cost for the satisfactory fulfillment of the contract, if so required.
2. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offerers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
3. Samples, duly listed, should be forwarded if called for under separate cover and the

unapproved samples got back as early as possible by the offerers at their own expenses and the Government will in no case be liable for any expenses on account of the value of the samples or their transport charges,

etc. In case, the samples are sent by railway; the railway receipt should be sent separately, and not along with the quotation since the quotation will be opened only on the appointed day and demurrage will have to be paid if the railway parcels are not cleared in time. Quotations for the supply of materials are liable to be rejected unless samples, if called for of the materials tendered for are forwarded. The approved samples may or may not be returned at the discretion of the undersigned. Samples sent by V.P. Post or "freight to pay" will not be accepted.

4. No representation for enhancement of price once accepted will be considered during the currency of the contract.
5. Any attempt on the part of tenderers or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the tenderers.
6. If any license or permit is required, tenderers must specify in their quotation and also state the authority to whom application is to be made.
7. The quotation may be for the entire or part supplies. But the tenderers should be prepared to carry out such portion of the supplies included in their quotation as may be allotted to them.
8. (a) In cases where a successful tenderer, after having made partial supplies fails to fulfill the contracts in full, all or any of the materials not supplied may, at the discretion of the Purchasing Officer be purchased by means of another tender/quotation or by negotiation or from the next higher tenderer who had offered to supply already and the loss, if any, caused to the Government shall thereby together with such sums as may be fixed by the Government towards damages be recovered from the defaulting tenderer.
  - a. Even in cases where no alternate purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the tender of the defaulter shall be forfeited and balance alone shall be refunded.
  - b. Any sum of money due and payable to the contractor (including Security Deposit returnable to him) under this contract may be appropriated by the Purchasing Officer or Government or any other person authorized by Government and set-off against any claim of the Purchasing Officer or Government for the payment of a sum of money arising out of or under any other contract made by the contractor with the Purchasing Officer or Government or any other person authorized by Government.

9. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
10. (a) Ordinarily payments will be made only after the supplies are actually verified and taken to stock but in exceptional cases, payments against satisfactory shipping documents including certificates of Insurance will be made up to 90 per cent of the value of the materials at the discretion of Government. Bank charges incurred in connection with payment against documents through bank will be to the account of the contractor. The firms will produce stamped pre-receipted invoices in all cases where payments (advance/final) for release of railway receipts/shipping documents are made through Banks. In exceptional cases where the stamped receipts of the firms are not received for the payments (in advance) the unstamped receipt of the Bank (i.e. counterfoils of pay-in-slips issued by the Bank) alone may be accepted as a valid proof for the payment made.
- (b) The tenderers shall quote also the percentage of rebate (discount) offered by them in case the payment is made promptly within fifteen days/within one month of taking delivery of stores.
11. Any sum of money due and payable to the successful tenderer or contractor from Government shall be adjusted against any sum of money due to Government from him under any other contracts.
12. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the purchases.

## **1. ITEM- MICROBIAL INCUBATOR**

1. View of samples through internal glass door, without impact on temperature
2. Convection technology Dual
3. Fan speed adjustable - 6 speeds
4. Microprocessor control
5. Automatic over temperature alarm (audible and visual)
6. Exceptional temperature uniformity
7. Containment with automatic over temperature alarm
8. Alarm for temperature deviations
9. Easy temperature setting with intuitive user interface
10. Easy to remove shelf system
11. Easy to clean interior with rounded corners
12. Easy to read large display
13. Efficient small footprint to optimize laboratory space
14. Efficient utilization of interior with flexible shelf system
15. The chamber should be made of Stainless Steel and should be easy to clean
16. The chamber external housing should be made of Corrosion resistant textured stainless Steel.
17. The internal volume should be be 50L-60L
18. The temperature range should be Ambient + 5 Deg C to 80 Deg C
19. The temp variation in time should be  $< \pm 0.3$  Deg C or better and temp uniformity should be  $< \pm 0.5$  Deg C or better at 37 Deg C.
20. The unit shall be fitted with minimum 2 Nos Stainless Shelves and there should be facility to accommodate total of 3 or more grids/shelves
21. The heating elements should be located on all 4 sides to ensure temp homogeneity inside the Incubator.
22. There should be provision for adjusting the fresh air intake by electronically adjusted air flap and the fresh air should be preheated before it enters inside the incubator to ensure that there is no sudden drop in temperature.
23. The controller should have a indication / setting accuracy of 0.1 Deg C or better.
24. The unit should be equipped with a Mechanical temperature limiter protection Class 1 to protect the Incubator from overheating in case of failure of the controller.
25. The unit should be equipped with a adjustable electronics over temperature protection controller
26. The unit should have 1 No PT 100 sensor for measuring the temperature.
27. The controller should have internal data logger/ ring memory capable of storing the test data for app 8 years or more.
28. The controller should have facility to be recalibrated without connecting to an external PC.

29. The controller should have a facility to display the temperature in either Deg C or Deg F as and when required
30. The unit shall be equipped with standard factory calibration certificate.
31. The unit should be able to work with 230 V +/- 10 % , 50 Hz Supply.
32. The unit shall carry a warranty of 2 years and 3<sup>rd</sup> year AMC contract to be provided.
33. CE/ISO 13485 for medical devices
